

MA Supplemental Nutrition Assistance Program (SNAP)

State Benefits Fact Sheet 2026 (October 1, 2025 – September 30, 2026)

How can SNAP help me?

The [Supplemental Nutrition Assistance Program \(SNAP\)](#) (formerly known as Food Stamps) is administered through the Massachusetts (MA) Department of Transitional Assistance (DTA) for people to buy nutritious food. Eligibility for SNAP benefits depend on household income and size.

Who qualifies for SNAP benefits?

MA residents who have a bank balance under \$2,001, or under \$3,001 if they live with a person who is age 60 or above or is disabled. To qualify for SNAP in MA, household income must not exceed **200%** of the Federal Poverty Level (FPL), and must have gross (before taxes) household income below the following amounts:

Household Size	Max Monthly Income	Max Annual Income
1	\$2,608	\$31,296
2	\$3,525	\$42,300
3	\$4,442	\$53,304

What is the maximum SNAP monthly benefit?

SNAP benefit amounts are based on earned and unearned income, including Social Security cash benefits and child support, as well as household size and expenses, e.g., medical, childcare and utilities. There are several deductions, such as the homeless and standard deductions, that can be applied to the SNAP calculation to determine monthly benefits. The following chart shows the maximum monthly SNAP allotment based on household size:

Household Size	Max SNAP Allotment
1	\$298
2	\$546
3	\$785

Will work impact my SNAP benefits?

Yes. The SNAP benefit amount will be subject to a reduction since total household income is counted in the SNAP calculation.

Do I have to report my work income?

Yes. You must report any income changes without delay to DTA to avoid overpayments, which must be paid back to the state. Failure to report work activity within 30 days of the date you started work could result in suspension of benefits for 6 months.

How can I verify my SNAP benefits?
